Ductless Heat Pump <sup>2</sup>	Electric Only	ENERGY STAR certified Single Indoor Unit: 20 SEER, 12.5 EER, 10 HSPF and AHRI Rated	\$500 per ton instant discount at point-of-sale to licensed contractors at participating equipment distributor locations only. Up to 5 tons per home.
Ductless Heat Pump <sup>2</sup>	Electric Only	ENERGY STAR certified Multi-Indoor Unit: 18 SEER, 12.5 EER, 9 HSPF and AHRI Rated	\$500 per ton instant discount at point-of-sale to licensed contractors at participating equipment distributor locations only. Up to 5 tons per home.
Boiler Circulator Pump	All Fuels	Approved models only: some Grundfos Alpha models, B&G, some Wilo models, etc. Please see the Qualified Products List (QPL) for a full listing of approved models	\$35 instant discount at point-of-sale to licensed contractor at participating equipment distributor locations only
Heat Pump Water Heater	Electric	ENERGY STAR certified with Uniform Energy Factor (UEF) of 3.0 or greater and < 55 gallons of storage capacity	\$750 instant discount at participating distributors
Heat Pump Water Heater	Electric	ENERGY STAR certified with Uniform Energy Factor (UEF) of 3.0 or greater and > 55 gallons of storage capacity	\$400 instant discount at participating distributors
Condensing Storage	Natural Gas Only	ENERGY STAR certified with Thermal Efficiency (TE) of 0.95 or greater	\$300 instant discount at participating equipment distributors
Tankless On-Demand	Natural Gas Only	ENERGY STAR certified with 0.92 Uniform Energy Factor (UEF) or greater	\$300 instant discount at participating equipment distributors
Wi-Fi Smart Thermostat <sup>3</sup>	Electric / Natural Gas	ENERGY STAR certified Wi-Fi enabled smart thermostat	\$100 instant discount at participating distributors. Up to three (3) rebates per eligible customer.

Boiler Reset Control	Natural Gas Only	Eligible for existing natural gas boilers only. Qualified models include Tekmar, Beckett, Honeywell, etc.	\$200 for existing systems only AND customer must have Home Energy Solutions assessment first
Central Air Source Heat Pump	Electric	16 SEER, 12.5 EER, 10 HSPF ENERGY STAR and AHRI certified	\$500 per ton (mail-in rebate) up to 5 tons per home
Central AC	Electric	16 SEER and 12.5 EER ENERGY STAR and AHRI certified	\$200 per system (mail-in rebate)
Geothermal	Electric	ENERGY STAR certified, see rebate form for more details	\$750 per ton and up to 5 tons maximum incentive amount (mail-in rebate) per home

Heat Pump Water Heater, ECM Boiler Circulator Pump, and Ductless Heat Pump installations in the town of Groton, Bozrah and Wallingford are not eligible for instant discounts.
